

## **Booster Club Meeting Minutes** **December 7, 2017**

**Attendance:** Jodi Schwedes, Sue Smith, Amy Burns, Diane Schulman and Nancie Romano.

Meeting called to order at 6:35pm by Jodi Schwedes.

**November Minutes:** Reminder to set up donation bucket for Camp Good Days for Hoops for Courage Game. Discussion about the change in time for meetings for the rest of the year: 3 people prefer meeting time to be at 7p, 2 people say either 6:30p or 7p. Decision was to table the official change until more members are present. Motion to approve minutes.

**Treasurer's Report:** *Jamie Frank not present at the meeting.* Question on report... What is the expense for *Dover* for? Amy reported that more money would be added to the Red Ram Run due to a credit. Discussion on excessive funds and when will we spend some money and check off items on athletic dept list. JDYAA also helping to buy items on list. Booster club and JDYAA will work together to make purchases. Motion to approve the treasurer's report.

**Athletic Director Report:** *John Goodson not present at the meeting.*

**Update on JD Booster Club Status:** The Booster Club has become its own entity. It is official, we are a LLC. 501c3 is pending. We can operate and let donors know it is pending. Discussion and clarification on why we needed to separate from the school district: There are many benefits for the club. District officials support the decision.

**Membership:** Diane had nothing new to report.

**Concession:** Sue shared that she loaded up a cooler with the remainder of drinks to be moved inside. Jodi will contact maintenance to move it on Friday. We still need to clean the outdoor concession stand. The coffee machine still needs to be

emptied. Starting balance should be \$200, not \$150. Booster Club cart is missing again. Jodi will call maintenance and ask them to find it and return it.

Reminder: Hoops for Courage Friday night for the JD and FM Basketball game. This program will benefit Camp Good Days. Discussed coverage of the stand.

**Concession Volunteers:** Nancie shared that she has no one to cover the shifts for Sunday's girls' basketball tournament due to wrestling team not filling their shift. It was decided that we should open. All agreed to help fill shifts. Diane will open on Sunday and get some breakfast items.

Filling shifts and finding volunteers continues to be a problem. Need support from coaches and TPR's. Discussion on how to motivate teams to fill shifts. Discussion on possibility starting a school club that students can volunteer in the stand. Plan to reach out to senior athletes in group messaging to help fill available shifts. Clarified: Students 13-16 can work in the stand with a parent. Over 16 can work alone. Under 13 not allowed to work the stand. Nancie will send an email at the end of each season asking parent volunteers if they would like to be on list of volunteers.

Discussion on openers and closers and board members' responsibility. Decision that we need to train others and get keys made. Amy got a key. A key to storage room closet should be kept in indoor concession stand safe.

**Logo:** *Mandy not present at the meeting.*

**Senior Banquet:** Jodi contacted Drumlins to book the date in June. Senior Banquet will be June 10 at 5p. Deposit will be needed when proposal is received.

**Fund the Red Rams:** The fashion show is March 11, 2018 at Drumlins. Maximum is 300 people. Letter to senior athletes will go out soon for interested athletes in walking in the show. The golf tournament will be at Fabius Pompey Golf Club on June 28<sup>th</sup>. We will be honoring the 1981 JD Football team. Rosters were passed out. Some discussion on what booster club will do to "honor the team". Plan to start working on a booster club website which will include PayPal and link for logo. Discussion on flash stores and profit from flash stores to booster club.

Desire to get all logo items from the same place and new website can facilitate this.

**New Business:** Desire to know Nets Tournament dates.
