November 7, 2019

Meeting called to order at 7:00 pm.

October Minutes: Sue motioned to accept the minutes from October and Jean seconded it. All other members approved the minutes.

Treasurer's Report: Jamie shared the treasurer's report. Our current cash on hand is \$68,770.00. Sue made a motion to accept the treasurer's report. Bob seconded it. All other members approved the minutes.

Concessions: Sue and Jean cleaned and moved all the food from the outdoor stand into the indoor stand. Eric will reach out to electric and ventilation companies to get estimates for the work we may want done in the indoor stand.

Memberships: Maria has written thank you notes for members that donated \$100.00 or more. Michele will contact her to request that she create an excel sheet with donors and amounts given to the All Sports Booster Club.

Communication: Mandy and John have been working hard on posting updates at various sporting events on our Facebook page. They continue to do the best they can to cover as many sports as possible. JD parents are encouraged to send information, updates, and pictures to Mandy.

Fashion Show: The event will be from 5-8 on November 24th. The event is being advertised through the school, local news, and social media.

Athletic Report: The district has been awarded the NYSPHSAA Scholar athlete Team School of Excellence Award from last fall. The girls' basketball team is requesting to do a "post-up" fundraiser. Using a poster board with numbers 1-20 on it, people will be able to buy a spot on the board. They are expecting to raise \$2000.00. This was approved. They will also do a poinsettia sale. If they don't raise enough money, they may do a Applebee's pancake breakfast fundraiser.

On December 7, the wrestling team will host a tournament and the All Sports Booster Club will run the concession stand. They would also like to plan a "Burn the Turkey" run. Wrestlers would solicit pledges and then run.

Katie Cappelletti is our female state rep for section 3. Ryan Vespi represents the boys for section 3. They are currently working on the important issue of mental health. They also have planned appreciation events for officials. Officials have been subject to verbal harassment by fans at all schools across the county. The All Sports Booster Club would like to help promote respectful

behavior towards officials. We talked about having students speak to parents at the parents meeting about adult behavior toward officials.

John shared with information about healthy fundraisers.

John shared quotes for upgrading PA system for the main gym and the auxiliary gym. The main gym quote is \$830.00. The quote to upgrade the PA system for the auxiliary gym is \$2150.00. Jean made a motion to approve the quoted expenditure to upgrade the PA system in the auxiliary gym. Bob seconded it. All other members approved this expenditure.

Logo: Bob is going to talk to the logo company to see about an easier way to report the money we are making from the gear that is bought on our site.

Bob made a motion to adjourn the meeting at 8:13pm and Sue seconded it. All other members approved this motion.

JD All Sports Booster Club Team Fundraising Policy

Any team who wants to fundraise money for tournaments, events, charity, equipment, or other team needs must follow the JD All Sports Booster Club Fundraising Policy as follows;

1. A head coach/team that wants to participate in any fundraising campaign must present their fundraising plan directly to the athletic director. The head coach of the team will be in charge of the fundraising effort and will complete the fundraising form with detailed information about fundraising project. Included on the form will be the monetary goal of the fundraising effort, specific details of the fundraising event, and total estimated costs (if any) that are associated fundraising event. **For each individual fundraising event no more than \$9,999.00 may be earned. For 10,000.00 or above requires board of education approval.** If the athletic director approves the plan, he/she will communicate the plan to the booster club.
2. 100% of the money collected from the fundraiser must be turned into the JD All Sports Booster Club treasurer who will keep track of each team's funds. The head coach can request funds for the specific fundraising expense at any time by completing a check request form. All receipts must be submitted within 30 days of expenditure of the funds.
3. When raising money for tangible assets, if the team meets or exceeds its fundraising goal, the Booster Club will deposit a bonus of 10% of the stated goal to the team account. Tangible assets are those that make improvements in some way to the individual team which will remain property of the district. Examples may be, but are not limited to equipment, uniforms etc.
4. If there are any funds left over in the team account that were not used for the specific purpose of the fundraising event that money will stay in the account for the team to use at a later date. The head coach can formally request to use these funds by completing a check request form. The request must be approved by the JD Athletic Director.
Please Note: At no time will left over money from a fundraising event by a specific team be moved to the general fund of the booster club.

5. Exclusion to any fundraising campaign: Teams are not allowed to sell any food item at any JD Athletic event as part of the fundraising efforts.
